The Context of Acts 26: Some Key Observations from Paul's Witness:

- o Truth-telling combats the ignorance floating around (21:28, 38; 24:5,12; 25:10,19; 26:25)
- o Christ's death and resurrection is central to our message (23:6; 24:15, 21; 25:19; 26:8, 23)
- Our own faith story is key giving a defense (apologia 22:1; 24:10; 25:8,16; 26:1,2,24)
 - 1. <u>Life Before Christ</u> (26:1 12)
 - 2. Encounter with Christ (26:13 18)
 - 3. Life in Christ Today (26:19 23)
 - 4. Joining God in His Witness (26:24 32)

Questions for Reflection and Discussion:

- i. It has been said that God almost always awakens longing in a soul before a person comes to faith in Christ. How does God awaken people to Himself? Can you think of someone in your life right now that is being 'awakened' (Eph.5:14)? How can we pray for you to be a witness to them?
- ii. Witnessing is not just about us telling our story. It is caring enough to listen to someone else's story. Jesus was a good 'listener' and a good 'questioner'. The Gospels record that He was asked 183 questions, but He asked 307 questions. Why is this an important feature of being a good witness? How does it change your view of sharing your faith?

- 1. Why did Paul want nothing to do with standing trial in Jerusalem? (25:10-11)
- 2. How was this meeting a fulfillment of the prophecy in Luke 21:12? (25:23)

- 4. Why do we tend to hold on to past grievances?
- 5. What does Paul's example of self-defense have to teach us?
- 6. How do you express yourself when you are on the defensive?
- 7. In what way did Paul's arrest help him spread the news about Christ?
- 8. Why might God allow us to suffer for no apparent reason?
- 9. How can we use stories of our own experience to share the message of Christ?

Apply It

- 10. What person or situation can you place in God's hands this week as a discipline against turning events to your own ends?
- 11. In what difficult situation do you want to remember that God is sovereignly in control?
- 12. What story of God's working in your life can you rehearse for sharing with others?
